Dear Parent(s)/ Guardian(s) and Students,

We would like to take this opportunity to make you aware of the arrangements for the Leaving Certificate Applied Mock Exams for LCA 2, beginning Monday 22nd January 2024.

Please note;

- All students must attend school at 8:40 on the morning of an exam.
- **Students will have two exams on the same day** must remain in school for the full day. As per the normal school rules students may not leave the school during the break between exams.
- **Where a student has an exam in the morning, but no exam in the afternoon**, in this case, with Parents/Guardians permission, students may leave the school when their morning exam is completed to go home to study. Only Students with a signed permission slip will be permitted to leave the school grounds. It is expected that when a permission slip is provided, study will be done at home.
- The permission slip needs to be signed, photographed and emailed to Tutor/ Year Head by Thursday 18th January. Only students who have provided a signed permission slip may leave the school.
- Students must stay in school for the full duration of all their exams.
- **Students must attend for exams in full uniform**
- If a situation arises in which a student leaves the school grounds without permission, the normal school sanctions will apply.
- In the interests of maintaining good relationships with the local community, we would ask for parents support in ensuring that students leaving the school early having completed exams would go directly home to prepare for future exams and not congregate around the village.
- Normal taught classes will resume on Tuesday 6th February for all students
- **LCA2 Mock Exams** take place Tuesday 23rd – Thursday 25th January. School will continue as normal for LCA2 students from Monday 29th January.

The purpose of the mock examination is to emulate state exam conditions. Therefore, we would ask that the student conduct himself/ herself in a proper manner throughout the examination period. Students should be prepared for each exam with all materials required. Registration will take place at the beginning of each exam, so it is essential that students arrive in plenty of time. A student that arrives late to an exam may not be permitted to enter the exam centre. Similarly, any student(s) causing disruption will be removed from the exam centre and prevented from sitting further mock exams.

We understand that this time of year is extremely busy for our 6th year students. It is normal to feel some pressure and apprehension before the mock exam. We remind students that this is a
